

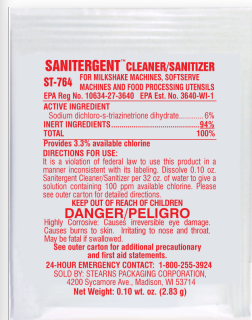
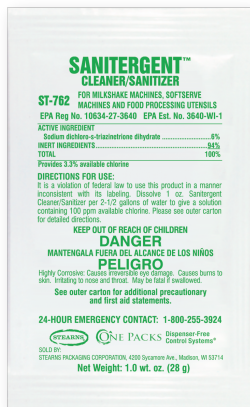

This material is very effective on table tops, tanks, vats, floors, walls, dishes, glasses, metallic utensils, and milkshake and soft serve machines.

It may be necessary to remove gross filth and heavy soil from surface by a pre-scrape, pre-flush and where necessary, a pre-soak treatment. Dissolve 0.10 oz. of Sanitergent™ Cleaner/Sanitizer per 32 ounces of water to give a solution containing 100 ppm available chlorine. Apply the sanitizing solution to the surface to be sanitized spray to wet all surfaces thoroughly. Let stand at least one minute. Air dry. The sanitizing solution should be used promptly after mixing. It should be prepared daily or more often if it becomes dilute or soiled. If the solution is allowed to stand and/or continued use shows the level of chlorine has not been maintained, add more Sanitergent™ Cleaner/Sanitizer to maintain a use solution of 100 ppm available chlorine.

Clean object to be sanitized with 1 to 2 ounces Sanitergent™ Cleaner/Sanitizer per 2-1/2 gallons of water and rinse well with potable water. It may be necessary to remove gross filth and heavy soil from surface by a pre-scrape, preflush and where necessary, a pre-soak treatment. Dissolve 1 oz. of Sanitergent™ Cleaner/Sanitizer per 2-1/2 gallons of water to give a solution containing 100 ppm available chlorine. Apply the sanitizing solution to the surface to be sanitized by immersion or flooding, to wet all surfaces thoroughly. Let stand at least one minute. Air dry. The sanitizing solution should be used promptly after mixing. It should be prepared daily or more often if it becomes dilute or soiled. If the solution is allowed to stand and/or continued use shows the level of chlorine has not been maintained, add more Sanitergent™ Cleaner/Sanitizer to maintain a use solution of 100 ppm available chlorine.
